# 2022-2023 NFHS SOCCER RULES CHANGES






Hair control devices and other adornments worn in the hair must meet the following criteria:


- Be securely fastened to the head.
- Do not present an increased risk to the player, teammates or opponent.
- This change promotes the inclusion of participants based on their cultural and religious beliefs.





In PlayPics A and C, the beads worn by each player are not securely fastened to the head. In PlayPic B and D, the beads worn are securely fastened to the head.











• In PlayPics A, the player cannot participate with the hair adornments worn in the current position since the adornments are not securely fastened to the head. Play Pics B and C are options to make legal.















- In PlayPics A, B, C and D, the hair control devices worn are securely fastened and are legal.
- In PlayPic E, the hair control device is illegal as it is not securely fastened to the head.







#### **EQUIPMENT AND ACCESSORIES** 4-1-6a



 Hair charms are considered jewelry and per rule 4-1-7 would not be permitted.



### **SUSPENDED GAME** 7-1-3



- State associations may adopt gameending procedures for suspended game.
- Unless set forth by state association adoption, unless tied, it is an official game if one complete half or more of the game has been played.
- State association procedures also govern games in which one complete half has not been completed




### GOALS 10-1-2f, 10-1-3h NEW



- A goal may not be scored directly from a goalkeeper's throw into the opponent's goal.
- A goal may be scored for the opponents when a goalkeeper throws the ball into the team's own goal.



#### HANDLING 12-2






For the purposes of determining handling offences, the upper boundary of the arm is in line with the bottom of the armpit.



# OFFSIDE DEFINITIONS OF PLAYING TERMS 11-1-1, 18-1-1s







**For** the purposes of determining offside, the upper boundary of the arm is in line with the bottom of the armpit.

- In PlayPic A, offside is judged by the upper boundary of #10's arm in line with the bottom of the armpit compared to #3 of the attacking team. #3 of the attacking team is not offside.
- In PlayPic B, even though #10's right arm is beyond #3's left shoulder, #3
  is offside. The position of the
  hand/lower arm is not considered
  when determining offside.
- In PlayPic C, even though part of #10's hand/lower arm is beyond #3's left leg, #3 is offside.



- When the ball is not kicked forward on a penalty kick, the defending team is now awarded an indirect free kick. The penalty kick is no longer retaken in this instance.
- Additionally, language changes were made to the Penalty Kick Situations Chart to more accurately describe a kick taken again as a Retake.



# CORNER KICK 17-1-2, 17-1-3



- Players of the defending team shall be at least 10 yards from the corner arc circle until the ball has been kicked.
- The distance is now measured from the corner arc instead of the ball.




# 2022-2023 NFHS SOCCER EDITORIAL CHANGES





### REQUIRED EQUIPMENT 4-1-1



4-1-1 was reorganized to assist with easier flow and understanding.

#### Shinguards must:

- Provide adequate and reasonable protection.
- Be professionally manufactured.
- Be age and size-appropriate.
- Not be altered to decrease protection.
- Be worn under the socks and worn with the bottom edge no higher than 2 inches about the ankle.
- Meet the NOCSAE standards at the time of manufacture.
- Additionally, shinguards must be worn properly.



# REQUIRED EQUIPMENT 4-1-1 (SOCKS)




- Teammates shall wear the same-colored socks.
- Visiting team players wear solid white socks
- Home team players wear socks of a single dominant color, but not necessarily the color of the jersey.
- If tape or a similar material (stays/straps) is applied externally to the socks, it must be of similar color as that part of the sock to which it is applied.
- If sock is modified by cutting off the foot of the sock, then any visible material worn under the sock and above the ankle must be of similar color to the predominant color of the sock.



### OFFSIDE 11-1-4b

11-1-4b was revised to clarify that offside shall be ruled if the player is gaining an advantage by being in an offside position.




In this MechaniGram,

### POINTS OF EMPHASIS





#### **SPORTSMANSHIP**



- The NFHS is concerned that unsporting behavior in education-based athletic has increased across all sports. As a result, the NFHS has made sportsmanship the no. 1 Point of Emphasis for the 2022-23 school year.
- The interscholastic coach is responsible for setting the tone at athletic contests and must act in a sportsmanlike manner.
- If coaches are complaining constantly about the decision of contest officials, spectators are likely to do the same.





- A positive, open line of communication between officials and coaches ultimately leads to better behavior by studentathletes.
- Good sporting behavior is expected before, during and after every contest.



#### **SPORTSMANSHIP**



- Contest officials should never engage with spectators who are exhibiting unsporting behavior. Instead, school administration, or in their absence, the home team's head coach is responsible for dealing with unruly spectators.
- The NFHS is concerned about unsporting behavior inhibiting the recruitment and retainment of officials.
- In addition, an environment with demeaning language, taunting and/or hate speech directed at players does not further the mission of education-based activity programs.



#### STRATEGIC TIME-WASTING TECHNIQUES

Time-wasting techniques disrupt the flow of the game and allow a team to gain an unfair advantage.

Officials must be aware of these tactics including:


- Goalkeepers holding the ball for longer than 6 seconds before releasing the ball into play.
- Delays on restarts such as free kicks or throw-ins. For example, when players take unnecessary time to set up a free kick or throw-in by re-tying their shoe or adjusting their uniform.
- Team excessively substituting before the 5-minute rule applies.



#### **PENALTY KICK**

- A stutter step or a hesitation move is permissible.
- The ball must be kicked forward.
- If the ball is not kicked forward, an indirect free kick is awarded to the defending team from the penalty kick mark.





Rule 12-8-1c defines dissent.

- Expressions of frustration or disappointment or private dissatisfaction not directed at anyone can usually be handled by a verbal warning or private discussion with the player.
- Simply disagreeing with an official's decision isn't always dissent. Several factors to consider in each situation.
- Continual public complaining, prolonged and repeated actions or personally directing comments at the referees must be dealt with.

#### MIAA RULES Handbook 2021 – 2023

- 78.1.3 Shin guards must be worn by all players during contests and practices.
- 78.1.4 Soccer players are not allowed to wear shoes with metal cleats, or any metal on the cleat.
- 78.1.5 Mouth guards are highly recommended for all soccer players while on the field.
- 78.1.6 The home team shall wear dark jerseys and socks, and the visiting team shall wear white or light jerseys and socks.
- 78.2.1 All leagues/conferences must conduct a pre-season meeting for all head soccer coaches to review sportsmanship goals and objectives.

### MISC MIAA RULES CON'T

- 78.2.4 Any player who receives a yellow card shall be replaced and shall not re-enter the contest until the next opportunity for substitution occurs.
- 78.2.5 A player committing a second yellow card infraction in the same contest receives a red card. There are no exceptions. It should be reported as only a red card (not two yellows or a yellow and a red).
- 78.2.14 A deliberate (intentional) handball to prevent a ball from entering the goal is a red card offense. However, the offender will be suspended from the remainder of that contest and only the next regularly scheduled contest.
- 78.2.16 For purposes of obtaining tournament eligibility, no team may exceed four red or fifteen TOTAL cards during the regular season.

  Delay of game encroachment and deliberate (intentional) handball are infractions, which will continue to be enforced and penalized. The impact of these infractions will be assessed and will be considered towards tournament ineligibility.

### MISC MIAA RULES CON'T

- 78.2.17 Any team whose players/coaches receive collectively five (5) yellow and/or red cards in a contest(including pre & post-game) will result in immediate termination of the contest, and result in forfeiture by the offending team.
- 78.2.18 The home team must complete the infraction score sheet IF any infractions given. The official must review and sign off on the information at the end of the game. The home team should keep this form for the remainder of the year. Each school is then required to enter all VARSITY infractions online through the MIAA Soccer Infraction reporting form found on the MIAA Soccer page. A hard copy of any coach/student disqualification form must be sent to the MIAA. (Sub-varsity level score sheets should be filed and maintained at the local level).

### MISC MIAA RULES CON'T

- 78.2.19 Game officials will not receive compensation unless they remain present at the conclusion of the soccer contest until the student-athlete handshake is completed.
- 78.2.21 For all varsity soccer contests, the home team must assign an adult contest manager, other than a member of the soccer coaching staff, to be responsible for all aspects of administration of the contest.
- 78.2.23 The MIAA Taunting Policy must be reviewed by game officials with the captains and coaches in a meeting before each soccer contest.
- 78.3.1 Contests shall consist of four 18-minute quarters, two 36-minute halves, or two 40-minute halves.

### **MIAA TIMEOUT RULE**

78.2.24 Each team will be allowed a one-minute time out per half and each extended time period. The time-out may be called by the coach or any player on the field during an offensive restart.

#### **Specifics:**

- One per half. One minute length
- Unlimited subs after timeout
- Called by team owning restart
- Called by either team after a card, goal, injury, dropped ball
- Non-cumulative
- No timeouts in shootout
- Injured player may return upon either team calling a timeout
- Cautioned player may not return until next legal substitution

The infraction sheet does NOT need to be submitted to the MIAA, the home team should keep them for their records for the entire regular and tournament season.

All disqualifications must be explained in writing immediately after the contest by the official and coach on separate forms to the Athletic Director and the Principal of the school. There are no exceptions for any coach expelled from a contest. If the game official fails to file his/her report, the coach is still bound by the suspension. He/she must be excluded from the next contest that is part of their regular season schedule or in tournament play. Disqualifications from ice hockey, soccer and baseball are for the next two contests.

#### **GUIDELINES FOR LIGHTNING SAFETY**



- Recognition: Thunderstorm development. Average distance between successive lightning flashes is approx 2-3 miles, anytime the lightning can be seen or thunder heard, the risk is already present.
- Flash to Bang Generally a 30 second or less flash-to-bang get off the field!
- Evacuation If lightning is imminent or a thunderstorm is approaching, EVERYONE shall evacuate to available safe structures or shelters.
- Safety Usually inhabited building with 4 walls, 2<sup>nd</sup> choice auto fully enclosed. Avoid touching metal parts of car while in it.
- Thirty-minute Rule Once lightning has been recognized, WAIT at least 30 minutes after the last flash of lightning or thunder is heard. Any subsequent lightning or thunder after the beginning of the 30-minute count should reset the clock and another count should begin.
